Re: 2025 Ballot for CSBA Delegate Assembly — **U.S. Postmark Deadline is Mon. March 17**

Enclosed is the ballot material for election to CSBA's Delegate Assembly from your region or subregion. It consists of: 1) the ballot (on red paper) listing the candidates, the reverse side of which contains the names of ALL current members of the Delegate Assembly from your region or subregion; and 2) the required candidate biographical sketch form and, if submitted, a resume. In addition, provided is a copy of the ballot on white paper to include with your board agenda. **Only the ballot on red paper is to be completed and returned to CSBA. It must be postmarked by the U.S. Post Office on or before Monday, March 17, 2025.**

Your Board may vote for up to the number of seats to be filled in the region or subregion as indicated on the ballot. For example, if there are three seats up for election, the Board may vote for up to three candidates. However, your Board may cast no more than one vote for any one candidate. The ballot also contains a provision for write-in candidates; their name and district or county office must be clearly printed in the space provided.

The ballot must be signed by the Board President, Board Clerk, or Superintendent as a designee of the board, and returned in the enclosed envelope; if the envelope is misplaced, you may use your district's or county office's stationery. Please write **DELEGATE ELECTION** prominently on the envelope along with the region or subregion number on the bottom left corner of the envelope (this number appears at the top of the ballot). If there is a tie vote, a run-off election will be held, and ballots will need to be postmarked on or before April 30. Results will be published by May 11, 2025.

For County Boards of Education Only:

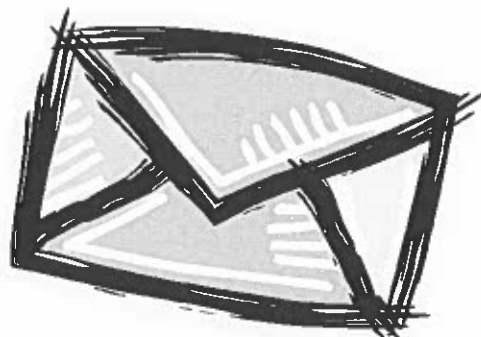
Per Standing Rule 52, in regions with more than one county, each county board of education has one vote to elect the county board member who represents the county board(s) in the region in the Delegate Assembly. One-county regions will appoint the county Delegate. Your county board may vote for only one candidate to fill the Delegate position representing the county boards within your region. Enclosed is the ballot material for election to CSBA's Delegate Assembly of the county board representative from your region. It consists of 1) the ballot (on GREEN paper) listing the candidates, the reverse side of which contains the name of the current member of the Delegate Assembly representing the county boards in your region; and 2) the required candidate biographical sketch form and, if submitted, a resume. In addition, also provided is a copy of the ballot on white paper to include with your board

agenda. **Only the ballot on GREEN paper is to be completed and returned to CSBA. Like the ballot on red paper for the other Delegate seats in your region, it must be postmarked by the U.S. Post Office on or before Monday, March 17, 2025.**

The ballot on GREEN paper must be signed by the Board President, Board Clerk, or by the County Superintendent, as a designee of the board, and returned in the enclosed envelope. If the envelope is misplaced, you may use your county office's stationery. Please write **DELEGATE ELECTION** prominently on the envelope along with the region number on the bottom left corner of the envelope (this number appears at the top of the ballot). If there is a tie vote, a run-off election will be held, and ballots will need to be postmarked by April 30. The results for the county board seat in each region will also be published by May 11, 2025.

All re-elected and newly elected Delegates will serve two-year terms beginning April 1, 2025 – March 31, 2027. The next meeting of the Delegate Assembly takes place on Saturday, May 17 and Sunday, May 18, 2025. 11. Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly. *

I want to serve the school districts in our region by raising the level of discussion about the specific issues and concerns that affect us in Region 20. My background in community public health, and the skillset that comes with it, has truly helped me look at issues with a sensitive, solution-driven perspective where the student and family are at the heart of the process. When designing community health programs, you need to understand the community you are serving down to the littlest detail if you want your program to be successful. Likewise, being active in the Santa Clara School Boards Association (SCCSBA) has allowed me to appreciate the insights of my fellow trustees in our county and understand both their unique and common challenges. At SCCSBA, where I am currently the Vice President, I have served as Hoffmann reader, Treasurer and recently joined the Legislative Action Committee (LAC). My experience includes service on my school board (current Board President and in 2021), serving on the board of the Asian Pacific Islander School Board Members Association (APISBMA), Vice Chair of the Santa Clara County Juvenile Justice Commission (current Chair of the Education and Equity Committee), and board member for the Eating Disorders Resource Center (EDRC) and Silicon Valley Urban Debate League (SVUDL). I have experience bringing diverse groups together. Districts working together, both within our region and outside of it, is key to creating the school and policy environments that positively impact our students. This is critical because our concerns cross school district boundaries. From the recent LAC survey, our districts let us know the top concerns in their districts, and addressing these needs is critical to closing the achievement gap, supporting special education and English learner students, and addressing our students' mental health and wellness needs.

12. Please describe your activities and involvement on your local board, community, and/or CSBA. *

I have been very involved in my community for many years. I have focused my activities on those that support and advocate for children and families. I became a trustee for just that reason. Before joining my board, I co-chaired successful bond and parcel tax campaigns. I am currently Board President and served as Board President in 2021, guiding the transition back to in-person classes. At LASD I served on the District English Language Advisory Committee and the Wellness Committee for several years. I served for three years on the board of the Asian Pacific Islander School Board Members Association (APISBMA), focusing on the needs of our API students. In the previous school year, I joined the leadership of the Santa Clara County School Boards Association, where this year I am the Vice President and member of the Legislative Action Committee (LAC). This particular role has given me insights into the issues that affect our diverse school districts. Since 2019 I have served as a commissioner on the Santa Clara County Juvenile Justice Commission (JJC), where at various points I chaired the Equity & Justice Committee, the Education Committee, and the Education & Equity Committee. In 2024 I became Vice Chair of the JJC. The JJC has given me access to county-wide organizations that focus on breaking the school to prison pipeline and re-integrating our justice-involved youth and foster youth back into their home districts. I also serve on the board of the Eating Disorders Resource Center and the Silicon Valley Urban Debate League (SVUDL). Serving on the SVUDL board in particular has challenged me to think more creatively about how we can address the achievement gap. I am currently also on the board of the Los Altos-Mountain View Community Foundation, where I serve on the Grants and Development Committees. I have served on the board of a mental health organization that served our students, CHAC, where I chaired the Development Committee for 2 years.

13. What do you see as the biggest challenge facing governing boards and how can CSBA help address it? *

The biggest challenge facing governing boards is closing an achievement gap whose root causes are increasing. Not surprisingly, the results of the recent Legislative Action Committee (LAC) survey, where each district was represented, showed that the top four issues facing our region are socioeconomically disadvantaged students, mental health and wellness, special education, and English learners. Each issue alone has an impact on the achievement gap, but the compounding of these issues creates a deeper challenge for governing boards. We need supportive legislative policies that help us address these issues collectively because these issues don't stop at the boundaries of our districts. Of course, lack of funding and unfunded mandates undermine our ability as school districts to address these challenges. Being an optimist, I believe that the opportunities are there as well. One of the best aspects of our county and state school boards associations is that they provide the space for our districts to come together, share their perspectives and insights, and allow for collective, systems-changing solutions to the challenge of closing the achievement gap.

13. What do you see as the biggest challenge facing governing boards and how can CSBA help address it? *

Therefore it is difficult to speak to one specific challenge facing governing boards in California and how CSBA can address it. Several of the challenges facing governing boards across the state are:

*Funding, budget shortfalls

*Declining enrollment, although this trend might be improving

*Recruitment/hiring/retention of teachers, staff and administrators - especially in DEI hiring to reflect student and school community population

*Proposed implementation of Project 2025 and the negative outcomes from this

*Health and well-being of students and school community

Through its mission, CSBA can help to develop and sustain strong governance teams from the district level, county and state-wide by providing support through training, professional development, strong coalition building, advocacy and policy analysis. Assisting local districts address their unique challenges, while looking at the greater and common good for all students across the state even if a particular issue does not directly impact them. Also, we need the DA to push forward more bold ideas about ADA reform, so that our funding models for school districts serve students better in high cost-of-living areas, such as the Bay Area. CSBA is one of the most powerful education lobbyists in Sacramento, so using the DA and our policy platforms to push the legislature to prioritize education with greater urgency will be essential as we enter a time when federal education funding will be in flux.

Lastly, I would like to strengthen local governance by creating more opportunities for trustees to gain training for budgeting and fiscal oversight, which is the core responsibility of being a trustee, next to keeping our communities and students safe. Thank you for your consideration and I hope I can earn your support to be re-elected to the CSBA Delegate Assembly.
