

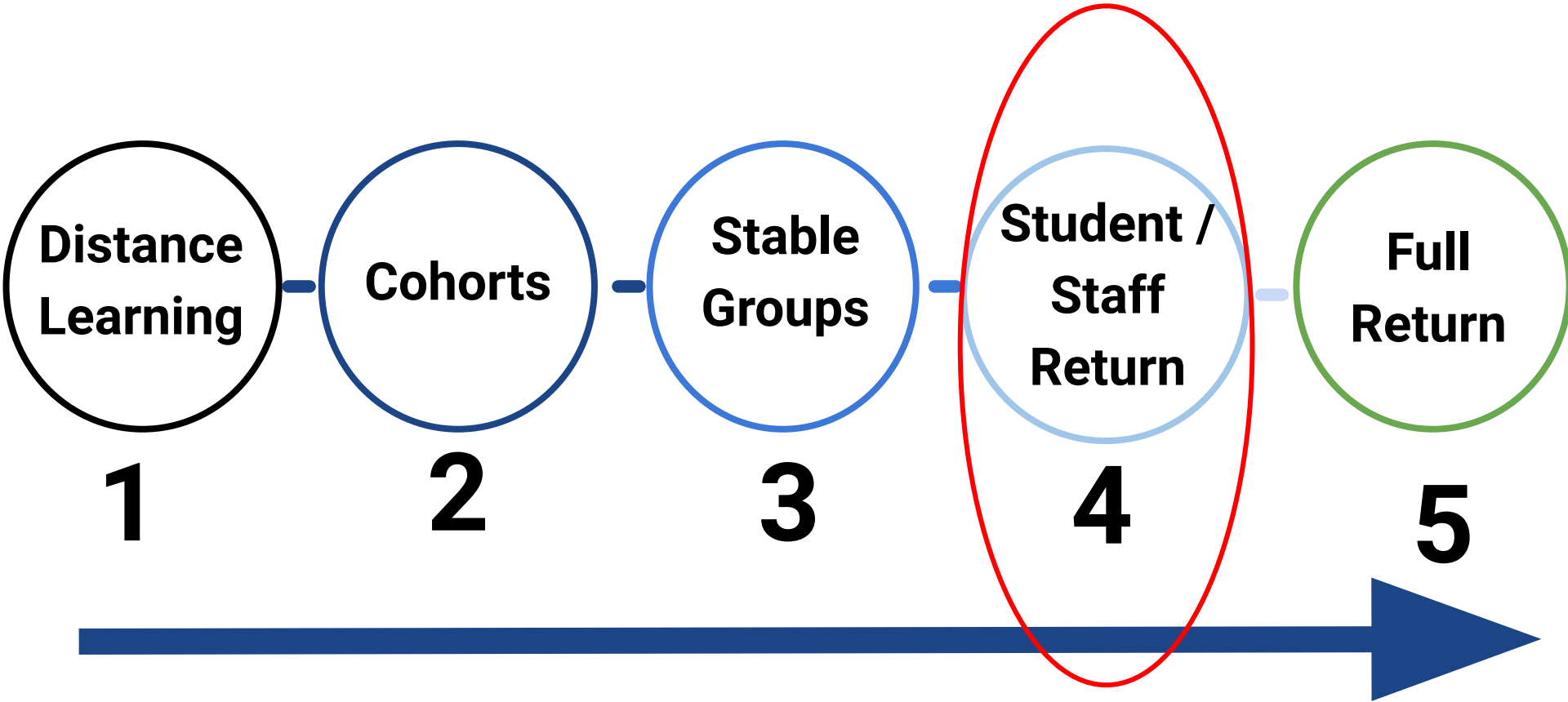

# MVLA Phased-In Return



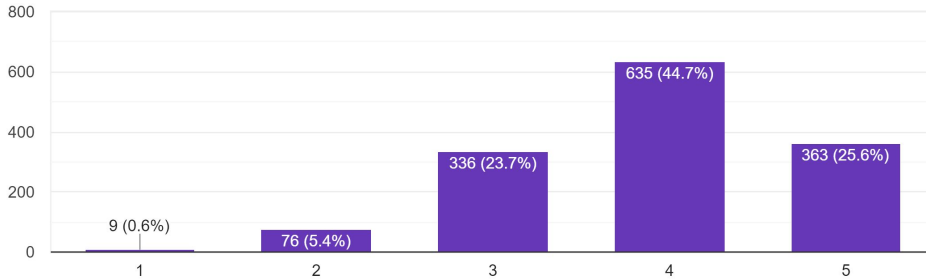

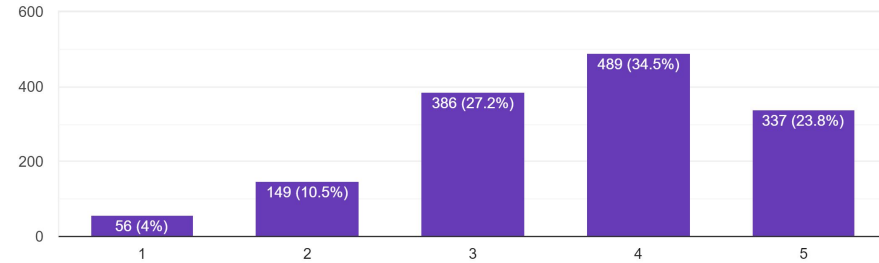

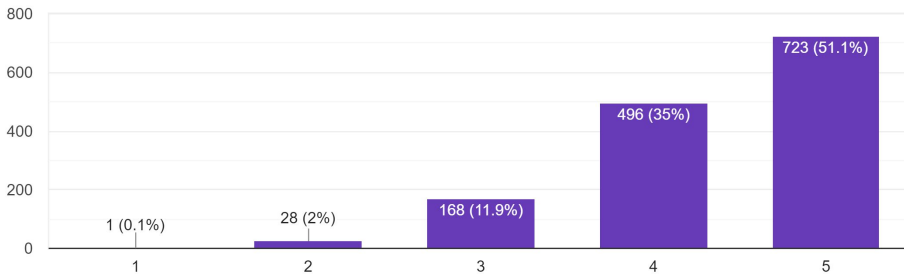

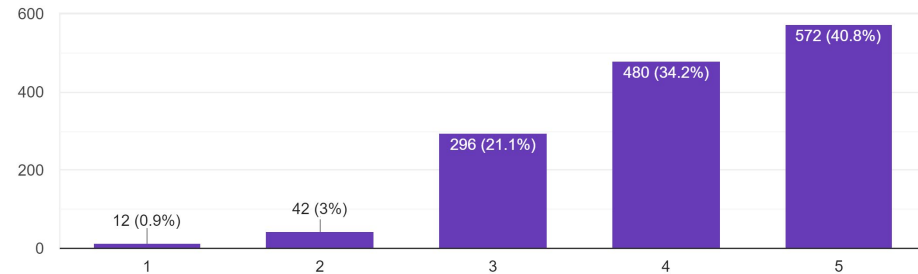

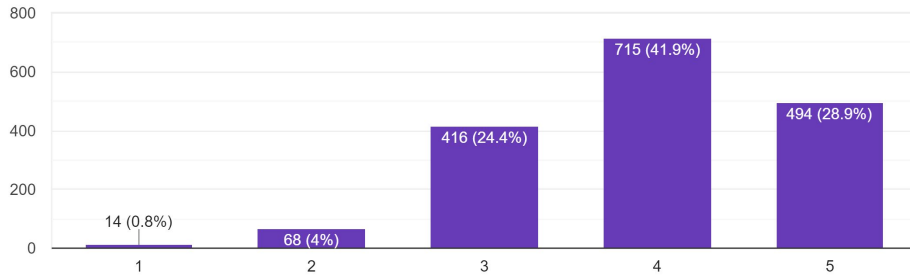

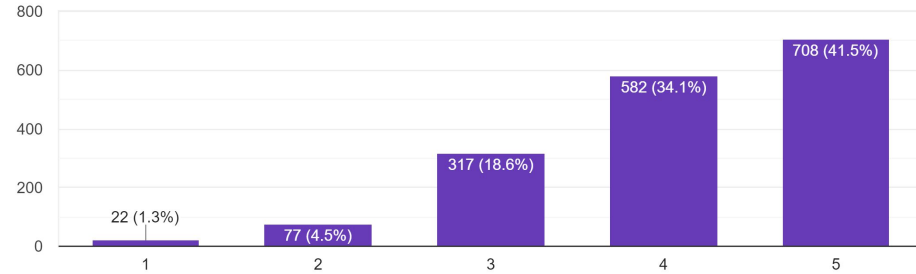

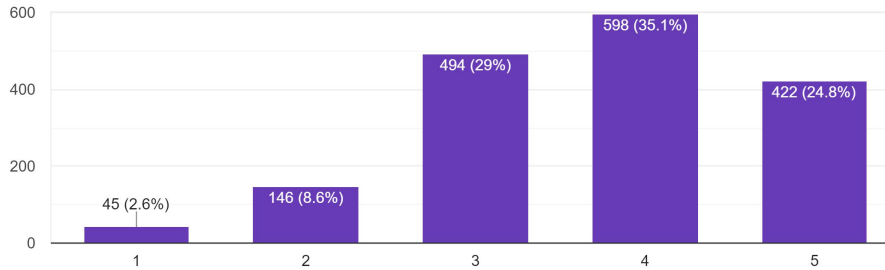
My ability to see my teacher/classmates in zoom / Mi capacidad de ver a mi profesor / compañeros en zoom

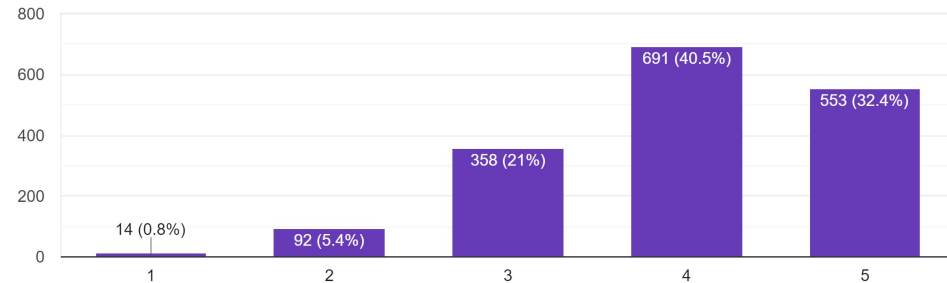

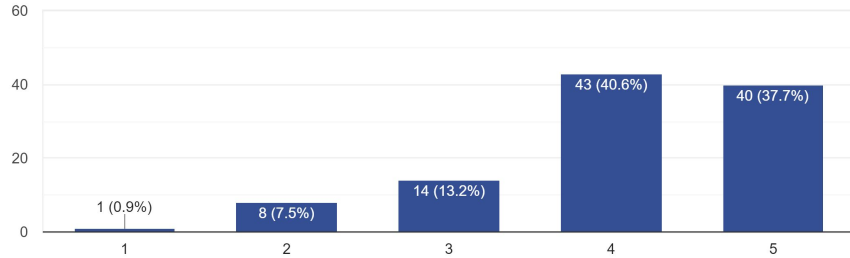

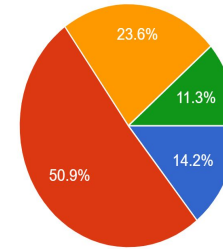

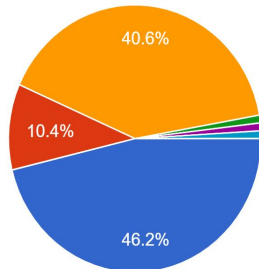

How did Simultaneous Teaching go for you?

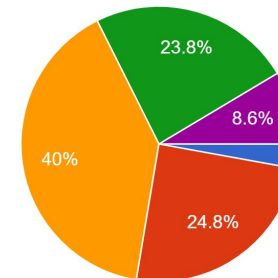

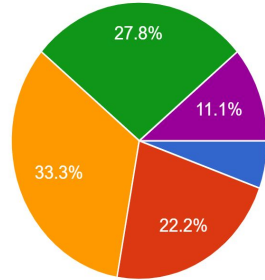

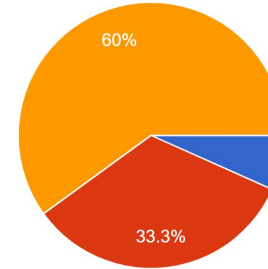

How was the experience with your sub supervising your classroom of roomie students?

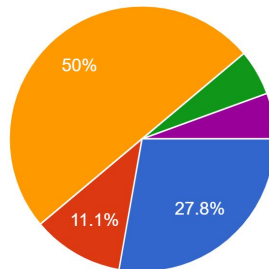

# MVLA Return to School: Facility and Classroom Safety Update

## In the **classroom**....



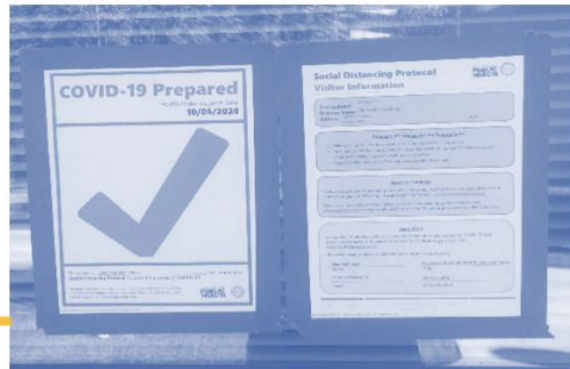
All students and staff must wear masks.

All desks are staged at least three feet apart.

“COVID-19 Prepared” checklists and other signage is in place to remind everyone on campus to wear masks and to practice social distancing.

Wall-mounted hand sanitizer dispensers are installed at doorways so students and staff can use upon entry and exit.

HVAC filters with a Minimum Efficiency Reporting Value (MERV) of 13 help filter out very small particulate matter – about 2.5 microns in size, just below hospital grade – are in all classrooms.



## Throughout the campus...



Decals on the ground remind people to maintain social distancing; additional signage remind students to knock and wait before entering certain facilities like main offices, financial aid offices, textbook rooms, and other spaces.



Numerous floor-stand hand sanitizer dispensers are in common areas. As the use of facilities changes, these dispensers can be relocated as needed so they are always available in higher-use areas.



Plexiglass shields are in all offices, especially those for transaction-type activity such as libraries, and finance and attendance offices. In some cases, the shields have small cut-outs to slide documents and materials back and forth.



Electrostatic sprayers disinfect spaces with a lot of surface areas. Sanitizers or disinfectants are charged as they pass through a sprayer nozzle, providing a uniform coating on the sprayed areas, including in hard-to-reach areas that manual cleaning can miss.

# COVID Positive Case / Close Contact

## **What if MVLA finds out about an exposure or positive case:**

When MVLA becomes aware of a school-related exposure, and your student is affected or considered a close contact, we will contact you via phone and email a letter with relevant protocols/next steps. If your student is on campus at the time, they will need to be picked up immediately.

We immediately collect all relevant data and issue letters to affected families with information needed regarding how to proceed.

Dashboard: All families can regard our District Dashboard for general information about positive COVID cases on campus.

If your child is a close contact, the 10-day quarantine is mandatory - even with a negative COVID case.

# COVID Positive Case / Close Contact

In cases where the family reports positive test or close contact exposure to the school site, Leyla Benson (MVLA COVID Designee) will be contacted and we will need the following information in order to advise regarding how to proceed:

- Date student was last on campus
- Best number to contact parent
- Any teams or clubs student is involved with
- Date of positive COVID test of student or positive close contact (when COVID test was taken not results received)  
Date of first related symptom (if applicable)
- Date of first family member symptoms (if applicable)
- Other household members ill and dates of positive tests (if applicable)

# Reporting cases to MVLA

## **How to report an exposure or positive case to us:**

If your student, who attends on campus instruction, activities and/or athletics, has tested positive for COVID-19 or has been exposed to a COVID-positive individual (close contact), please email/call the principal immediately. Leyla Benson, COVID Designee, can also be contacted [leyla.benson@mvla.net](mailto:leyla.benson@mvla.net). Please keep your student home and await further notice.

## Testing partnership through El Camino:

Testing is important for a safe return and El Camino has partnered with MVLA to offer "no Out-of-pocket cost" COVID tests on site and in their clinic. The next testing dates are:

- Thursday, May 6, from 8:30 a.m. - 1:00 p.m. at the Los Altos High School cafeteria
- Tuesday, May 18, from 8:30 a.m. - 1:00 p.m. at the Mountain View High School cafeteria
