Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.

I have served on the Campbell Union School District's school board for 17 years and have been a delegate for Region 20 for the past 12 years. I have served on my Board's Intergovernmental subcommittee where we meet with the leadership in the six cities that our district serves. I am a board member for the 100 Women Charitable Foundation which gives grants to local non-profits working with under-served populations in the areas of Education, Family and Health & Wellness. Additionally I volunteer as a VITA tax preparer and as a tutor trainer for Elevate Tutoring, a non-profit working with low income

What do you see as the biggest challenge facing governing boards and how can CSBA help address it?

For 2021 the biggest challenge has to be the pandemic and its impact on our communities - families, staff and students. This goes beyond the obvious academic impact, as we must address the financial, social-emotional and health impacts to all as well. This will require a coordinated effort throughout the state with supportive policies and funding, for all areas impacted. # Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.

The Delegate Assembly plays a vital role in informing CSBA's policy positions at the state level. I am running to be a delegate for Region 20 so that I can push for resources and policies that will serve all of our students. As a national award winning elementary school teacher, my career in education spans the past eighteen years and includes working in education policy research, teaching, and running programs in K-12 settings. In my first two years as a board member and now Board President, I put my background in city planning to good use advocating for students at the local, regional, and state levels.

#### Please describe your activities and involvement on your local board, community, and/or CSBA.

I co-founded the Digital Equity Coalition (DEC) in March 2019. We brought together school board members from 30 of our region's 32 districts to successfully advocate for funding to help close the digital divide for Santa Clara County students; the County Board of Supervisors approved \$7.1 million to purchase hotspots, devices, and data plans for more than 15,000 families identified by the SCCOE.

I completed the Masters in Governance in 2019 and faithfully attend the AEC each year. This will also be my third year serving as a Hoffman Reader for the SCCSBA annual Hoffman Awards. Before running for school board, I served on Mountain View's Parks and Recreation Commission.

#### What do you see as the biggest challenge facing governing boards and how can CSBA help address it?

Governing boards are making life and death decisions during a global pandemic. We are negotiating safe working environments for our teachers and staff - PPE, testing, vaccinations, class size - while at the same time many districts face declining enrollment, rising costs and decreasing revenues. Getting children safely back to school is hands-down the biggest challenge we face right now. Getting every child the resources they need to thrive in school during and after this traumatic crisis will be our ongoing challenge for years to come.

The current pandemic is clearly our biggest challenge today. Besides the obvious financial impacts, we are seeing a huge loss in educational opportunities for our students, especially those that can least afford it. It has also made several long running, systemic issues much more visible that demand immediate action. CSBA can help in several ways, including: (1) driving our state government to provide leadership and financial support to our schools to get kids back in classrooms as soon as possible, (2) ensure that education remains a top priority for our state and that we see funding to support that priority, and (3) providing support and resources to school boards working to understand and solve these systemic issues that plague our schools.

# Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.

I believe that smaller districts need to be represented, especially those who are ADA funded. Smaller districts have their own unique needs, having to provide all services to all students with, many times, little extra funding to do so. In a time of declining enrollment it makes it even more challenging. Constantly having to reduce the District budget while maintaining top quality education has proved very challenging. I have been heavily involved in volunteering in Cambrian, from working in the classroom, to being elected President of the Home and School Club. It gives a perspective of what is working and where help is needed. I have a child with special needs and have been heavily involved in the special needs community, both as a parent and a professional.

#### Please describe your activities and involvement on your local board, community, and/or CSBA.

From my first year as Trustee, I served on the Faciliites Committee, overseeing the spending of our bond and the reopening of a school. I have worked on numerous measures within the district, both Parcel Tax and Bonds. I sit on the Board Policy committe where all our board policies and procedures are being reviewed and updated. I was also involved in the Technology Task Force where a 5 year Technology Plan was created for our district. I have completed all the Masters in Governance courses and am a regular attendee of SCCSBA meetings as well as the AEC every year. I also serve on the Branham High School Site Council. I represent Cambrian on our West Sides Board which is made up of a board member from 3 of our surrounding elementary districts and one from the high school district. It give us the opportunity to learn from eachother and ensure our students are being well prepared to enter high school.

#### What do you see as the biggest challenge facing governing boards and how can CSBA help address it?

The biggest challenge today and for all my previous time on the Board is a balanced budget. As mentioned earlier, with the uncertain state and federal funding and increased salaries and benefits and new curriculum, combined with declining enrollment, the challenge is huge.

Covid 19 has added to the challenge, requiring upgraded HVAC and facilities and PPE. When and how to reopen schools also adds to the challenge, with the uncertainty of when normality will return.

Another area that is near and dear to my heart is learning a second language. In a global economy it is so important to understand other languages. The challenge is to find certificated second language teachers. Having the state provide a stable funding that is more representative of the true cost of education, adjusting funding in areas with a high cost of living and providing incentives for teachers to enter second language certifications would be a big step in meeting some of the areas I view has high need.

# Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.

While we represent the region as a whole, there are unique aspects of our communities that need to be represented on CSBA's policy-making bodies. #### Please describe your activities and involvement on your local board, community, and/or CSBA.

I have also led various district measures to expand our offering to the students we serve in East San Jose. In 2017, I introduced the measure that prompted Alum Rock to create our first Vietnamese Dual Language Immersion School. I also led the effort to expand Alum Rock's Spanish Dual Language Immersion program by opening a second Spanish Dual Language Immersion School. Early in my tenure on the board, I established a partnership with the City of San Jose to renovate regional recreational facilities targeted by charter schools for further expansion. My service on CSBA's delegate assembly has allowed me to develop a closer relationship and work collaboratively with school board members. Whether it's serving as a validator for the Golden Bell Awards or assisting on other projects, I have learned to value what I know from my counterparts from different parts of the county.

#### What do you see as the biggest challenge facing governing boards and how can CSBA help address it?

At present, the biggest challenge for all of us is to stem the learning loss that results from the shift to virtual learning. Our teachers have been great and work diligently to provide a quality and dignified education to all of our students, whether in person or virtually; however, we cannot deny that our students have been impacted by the shift to a completely different delivery for their education. Furthermore, in our district, we have essential workers that are the most severely affected by the ravages of COVID-19; they are construction workers, grocery store employees, all of who do not have the option to telecommute. As a district, we have had to develop methods to support those essential workers that do not have other means to care for their children. CSBA can continue to advocate for more resources to all districts, especially those that are disproportionately impacted by COVID 19.

Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.
