SUBJECT: Resolution Number 22-10

Declaration of Need for Fully Qualified

Educators, REVISED

BACKGROUND INFORMATION: The original Declaration of need for 2021-22 was submitted and approved in June. Since the California Commission on Teacher Credentialing has expanded the Limited Assignment portion, there is a need to revise for additional Limited Assignment Permits. The Board of Trustees must vote to approve each submittal of the Declaration. Action on this resolution must be taken separately. This required action may not be acted upon under the consolidated motion.

REPORT/PROPOSAL: Educators who serve in public schools are required to hold an appropriate credential and/or authorization for their teaching or service assignment. When a credentialed educator is not fully prepared or otherwise legally authorized for their particular assignment, many Local Education Agencies (LEAs) seek a legal authorization that includes a pathway toward full preparation in the new authorization area by using one of the emergency or limited assignment in order to meet an acute staffing need in the district. Education Code (EC) § 44300 authorizes the Commission to approve a school district's request for the assignment of credentialed individuals who are less than fully prepared if the school district certifies it has conducted a diligent search for a fully credentialed educator and cannot attain one. The Board of Trustees must now establish a Declaration of Need for 2021-22 (revised). The possible need for the following positions is anticipated:

- WHEREAS, the needs of the District for 2021-22 have been assessed and the areas of possible need are: CLAD, Limited Assignments (7) and Resource Specialist
- NOW, THEREFORE, BE IT RESOLVED, that the Mountain View Los Altos High School District Governing Board of Trustees approve the Declaration of Need for Fully Qualified Educators.
