Effective June 1, 2021, the following changes set out below are made to Attachment 2 to the ThoughtExchange Terms of Service Agreement.

Section 3 of Attachment 2 is hereby amended by adding the following Clause 3.4 thereto:

The terms of this Agreement do not permit you to: (a) sublicense the ThoughtExchange platform or any related services; (b) transfer or otherwise grant any rights in or to your right to access and use the ThoughtExchange platform or any related services to any other person; (c) provide Exchange Leader account access to any person outside your organization other than your consultants or similar individuals who are in a fiduciary relationship with you; or (d) run, facilitate, analyze or present any Exchanges on behalf of any third-party. If you wish to do any of the foregoing, you must enter into a separate sales partner agreement with us.


