## **Engagement**

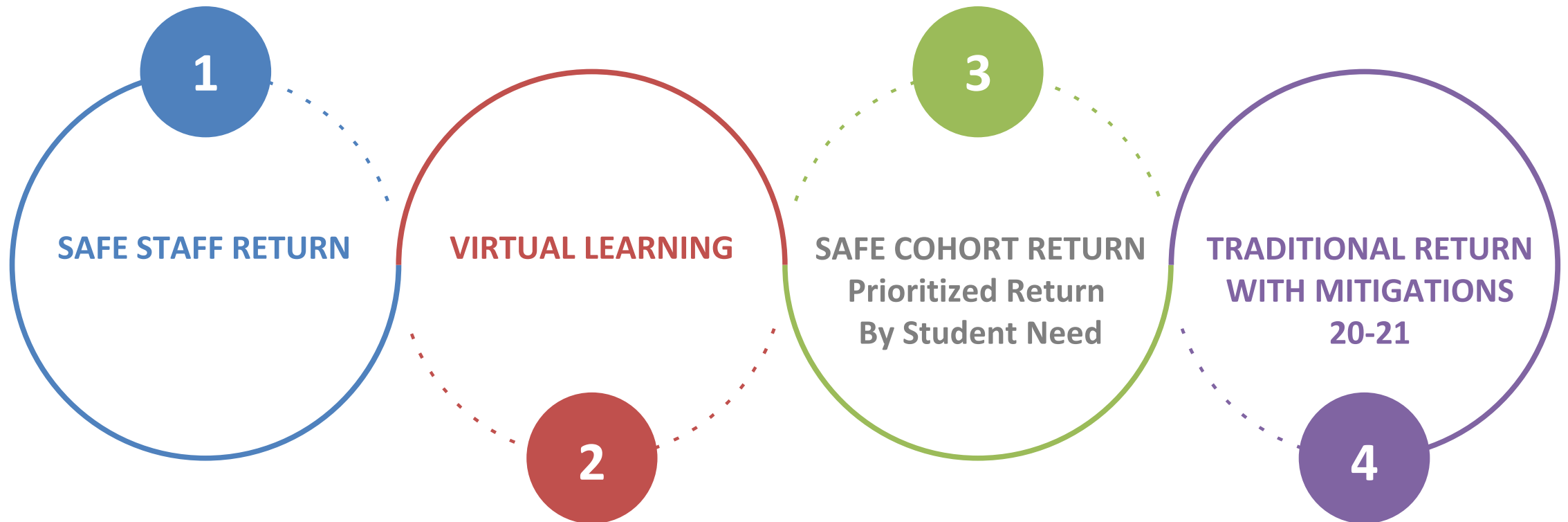

## MVLA Update: State of CA Office of Public Health Order

Governor Gavin Newsom ordered counties on the State's Coronavirus Watch List to shut down school campuses this fall, as we begin the school year.

Counties on the list must switch to virtual instruction only.

Mandate applies to private and public schools.

MVLA High Schools will open with Distance Learning.

MVLA Board of Education unanimously approved this staff recommendation on July 16, 2020.

# What Occurs When a Student or Staff has COVID-19

## Symptoms:

Fever, Cough, Loss of Taste or Smell, Difficulty Breathing

Symptom Screening Follows CA School Sector Specific Guidelines

## Action:

- Send Home
- Recommend Testing

School/Classroom remain open

# What Occurs if Student/Staff Member have Close Contact with a Confirmed COVID19 Case?

## **Action:**

- Send Home; Quarantine for 14 days from Last Exposure
- Recommend Testing (but will not Shorten 14 Day Quarantine)

School/Classroom Remain Open

# What Occurs When There is a Confirmed COVID-19 Case Infection?

## Action:

- Notify the Local Public Health Department
- Isolate Case/Exclude from School for 10 Days from Symptom Onset or Test Date
- Identify Contacts; Quarantine & Exclude Exposed Contacts for 14 Days After the Last Date the Case was Present at School while Infectious
- Recommend Testing of Contacts, Prioritize Symptomatic Contacts (but will not Shorten 14 Day Quarantine)
- Disinfection and Cleaning Where Case Spent Significant Time

School Remains Open



# What Happens When Someone Tests Negative after

## **Action:**

- May return to school 3 days after symptoms resolve
- School/classroom remain open
- Consider school community notification if prior awareness of testing

## MVLA Update: Criterion for Closing School

School closure is recommended based on number of cases, and percentage of the teacher/students/staff that test positive for COVID-19, and following consultation with the Local Health Officer.

School closure may be appropriate when there are **multiple cases in multiple cohorts at a school or when at least 5 percent of the total number of teachers/student/staff are cases within a 14-day period**, depending on size and physical layout of the school.

The local Health Officer may also determine school closure is warranted for other reasons, including results from public health investigation or other local epidemiological data.

## MVLA Update: Criterion for Reopening School

### **If a School is Closed for In-person Learning, When May it Reopen?**

Schools may Typically Reopen After 14 Days and the Following Have Occurred:

- Cleaning and Disinfection
- Public Health Investigation
- Consultation with the Local Public Health Department

## MVLA Update: Criterion for Closing/Reopening District

### **Closing:**

A Superintendent Should Close a School District if **25% or More** of Schools in a District have Closed Due to COVID-19 within 14 Days, and in Consultation with the Local Public Health Department.

### **Reopening:**

Districts may Typically Reopen after 14 Days, in Consultation with the Local Public Health Department.

# MVLA Update: Funding Sources Specific to Supporting Coronavirus

Senate Bill 117 - **\$73,698**

Elementary and Secondary School Emergency Relief (ESSER) - **\$207,598**  
(Preliminary Allocation)

Learning Loss Mitigation Funds - **\$2,1267,638** (School Services Estimate)

Allowable Uses:

- Student Learning Supports
- General Measures that Extend Instructional Time for Students
- Provide Additional Core Academic Support for Students Who Need it
- Provide Integrated Services that Support Teaching and Learning—Student/Staff Technology Needs, Mental Health Services, Staff Professional Development, and Student Nutrition

## MVLA Update: Technology Ongoing District-wide Support

- Canvas Learning Management System
- License for Continued Use of Zoom (in Addition to Google Meet and GoToConnect also Available for no cost to MVLA staff)
- Set up a Virtual Server to Support Remote Access to Computer Science, Engineering, and other CTE Courses that Require Specific Software
- GoToAssist: Allows the Tech Team to Create Remote Sessions with Staff or Students to Troubleshoot Hardware and Software Issues.

# MVLA Update:

## **Staff Technology**

- Purchased 190 New Laptops
- All Machines are Running our AMP (Advanced Malware Protection) Software to Avoid any Future Cyber-threats
- Access to Classroom Technology and Supplies

## **Student Technology**

- Purchased 250 Additional Chromebooks, plus the 650 new (Total of 900 New Devices Available for Checkout Beyond those Checked Out to Students)
- 225 Mobile Hotspots

# Full Distance Learning Fall 2020

- ❑ Checkpoints: Every 4-6 Weeks
- ❑ Allow for Staff Return when Safety Measures can be Fully Implemented
- ❑ Allow for Cohorts of Students to Return for Specialized Support
- ❑ Increase Budget for Professional Development
- ❑ Provide Continued Summer/Fall/Spring Professional Development
- ❑ Increase Safety Precautions: Cleaning, Protective Masks, Structures, Venues, Protocols
