For 40 classroom doors that were changed from wireless to wired access control locks, furnish and install new electronic power transfer devices and continuous hinges, and perform all necessary prep work on each door and frame to accommodate the wired system. 2. For 11 locker room exterior doors that were not previously specified to include access control locks, furnish and install all necessary components, including but not limited to: cylinder cores, door pulls, mounting brackets, door sweeps, kick plates, door closers, electronic power transfer switches, and continuous hinges supporting the power transfer, and perform all necessary prep work on each door and frame to accommodate the wired system. 

Hi Mike, hope you're doing well. Happy Wednesday! Based on our discussion last week, please see below the revised email for detailed explanation and cost breakdown for the door hardware PCO:

Attached is Work Directive WD 029 – PCO 014, which outlines proposed changes to doors related to the switch from wireless to hard wired locks and changes made to the construction drawings and specifications compared to the bid documents. The proposed change order (PCO) is an additional expense of \$85,470.00.

After several discussions with QKA and Rodan Builders, we've come to a shared understanding that this proposed change has merit. The bid documents had some inconsistencies—especially between the drawings and the specs—where both wireless and hardwired access control systems were shown, resulting in some necessary work not being included in the contractor's original bid. Addition of wired locks and associated door components and prep work to the locker room doors is as part of this change.

Multiple reviews were conducted between Cumming Group, QKA, and their consultant (TBD) to verify that there is no duplication of costs between the contractors' schedule of values (SOV) and the proposed change order, and the variance is reasonable (within 10%) in comparison to TBD's construction estimate.

Here's a breakdown of what's included in the PCO:

- Material and Labor for installing a new electronic power transfer device, a continuous hinge to support the power transfer, and prep on the doors and door frames for 40 classroom doors.
- Material and Labor for installing all the door components including but not limited to cylinder cores, door
 pulls, mounting brackets, door sweeps, kick plates, door closures, electronic power transfer switch, and
 continuous hinge supporting the power transfer, and prep on the doors and door frames for 11 locker room
 doors.
