FOURTH AMENDMENT TO PHYSICIAN CONSULTING SERVICES AGREEMENT

This Fourth Amendment to the Physician Consulting Services Agreement (this "Amendment") is effective as of September 1, 2020, (the "Amendment Effective Date") by and between Lucile Salter Packard Children's Hospital at Stanford, a California nonprofit public benefit corporation ("LPCH") and Mountain View-Los Altos Union High School District, a California public school district (the "District") with respect to the following:

RECITALS

WHEREAS, LPCH and the District are parties to a certain Physician Consulting Services Agreement effective September 1, 2014, as amended, pursuant to which LPCH, through its arrangement with Stanford University School of Medicine, makes the professional consulting services of its psychiatrists available to the District's students in accordance with the terms and conditions set forth herein; and

WHEREAS, LPCH and the District desire to extend the term of the Agreement and update the compensation, as set forth herein.

NOW THEREFORE, in consideration of the mutual promises and covenants of the parties set forth herein, LPCH and the District agree as follows:

AGREEMENT

- 1. <u>Term.</u> Section 7.1 of the Agreement is hereby amended to extend the term of the Agreement for one (1) year, expiring on August 31, 2021.
- 2. <u>Compensation</u>. <u>Exhibit D-3</u> to the Agreement is hereby deleted in its entirety and replaced with the <u>Exhibit D-4</u> attached to this Amendment.
- 3. <u>Continuation of Agreement</u>. Except as specifically amended by this Amendment, the Agreement shall continue in full force and effect, and the parties shall comply with the terms and conditions of the Agreement as existing on the date of this Amendment.
- 4. <u>Defined Terms</u>. Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement
- 5. <u>Conflicts</u>. In the event of any conflict between the terms and provisions of this Amendment and the terms and provisions of the Agreement, the terms and provisions of this Amendment shall control.
- 6. <u>Reference</u>. The terms and provisions of this Amendment are incorporated by reference in the Agreement as though fully set forth in the Agreement. After the date of this Amendment, any reference to the Agreement shall mean the Agreement, as amended by this Amendment.
- 7. <u>Counterparts</u>. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.

EXHIBIT D-4

COMPENSATION

In consideration of the performance of Professional Services provided by LPCH, through Physicians, Education Authority will pay LPCH at the rate of Seventy Thousand Three Hundred Ninety-Six Dollars (\$70,396) for the 2020-2021 contract year (September 1, 2020 – August 31, 2021), in monthly installments of Five Thousand Eight Hundred Sixty-Six Dollars (\$5,866) per month.

The annual fee reflects the provision of an average of eight (8) hours of remote or in-person professional services per week by LPCH fellows and an average of two (2) hours of remote or in-person supervision services per week by an attending physician, during each month of the contract year, with occasional reductions due to school and Stanford University holidays. In addition, the annual fee covers three (3) hours per month of at-large clinical consultation for counseling staff by Dr. Shashank Joshi, Director of the School Mental Health team, for the months of September through May.
