May 17, 2021

The DTA and the District have completed negotiations process for the 2020-21 school year, and have reached the following tentative agreement for the 2020-21 school year. The terms of the existing collective agreement will continue without change except for the modifications specifically described in this tentative agreement and the separate Supplemental Memorandum of Understanding regarding Covid-19 working conditions dated March 24, 2021. The negotiating parties will recommend this tentative agreement to their respective authorizing bodies.

Net Increase (decrease) in District's medical insurance and STRS payment	( <u>0.70%)</u>
Total Compensation Increase for 2020-21	3.55%
Additional non-recurring lump-sum payment based on the 2020-21 schedule	2.0 %
