- D. Torok noted that she pulled these items in order to inquire about the funding for these projects. Mike Mathiesen, Associate Superintendent of Business Services, explained that part of the cost would be paid from the district Building Fund, and that the total amount does not exceed the balance of the Building Fund. D. Torok requested an overall budget and timeline of how the district will pay for this, noting If the district was going to approach outside entities for a contribution, the entities would need to factor this into their fundraising efforts. President Faillace suggested that M. Mathiesen present the report previously shared and invite the entities to attend.

"Educational equity means that each child receives what he or she needs to develop to his or her full academic and social potential." C. Vonnegut Moved; S. Dave Seconded; and the Board voted 5-0-0 (with two Preferential Ayes from student Trustees) to adopt the definition of equity in education.

# 3. Mountain View City/School Strategy
