Trustee F. Walter reported that she attended a class at Los Altos the previous Friday morning. She shared she enjoyed hearing an urban planning final presentation judged by an industry panel with awards given to top presentations. Trustee Walter noted that the judges held students to a high measure and posed a lot of thoughtful questions to the presenters.

Trustee D. Torok reported that she and Trustee F. Walter attended Mountain View High School's production of "The Servant of Two Masters", and found it to be very entertaining.

SUPERINTENDENT'S REPORT

10.1 <u>Superintendent's Report</u>

Superintendent Dr. Nellie Meyer reported:

- The Los Altos Student Art Fair display of student art compared to that found at San Francisco's MOMA. (She shared photos of student art.)
- The first season of sports was very successful and playoffs ensued.
- Dr. Meyer shared that City Strategy has been a topic of conversation with the Board. She explained the anticipated redevelopment over the next 5-10 years may yield an increase of 1,000 additional students, which the district needs to plan for.
- Dr. Meyer was invited to speak about MVLA at a recent City Council Meeting.
- Topics at the Challenge Team meeting the prior week included how to work with students and how to be proactive about wellness. Trustees F. Walter and C. Vonnegut were in attendance. Dr. Meyer noted that the Challenge Team is a great partnership with the local cities, hospitals and other community organizations.
- Dr. Meyer shared that the Speaker Series event on vaping was held on November 14, 2019, and yielded enlightening information for attendees. Speaker Dr. Bonnie Halpern-Felsher spoke to a full audience. The next Speaker Series event will be January 28, 2020, at Mountain View High School. Dr. William Stixrud and Ned Johnson will present *"The Self-Driven Child: The Science and Sense of Giving Your Kids More Control Over Their Lives"*.

- Health: Immunizations, SB 276 (Pan D), Immunizations: Medical Exemptions. Status: 9/9/2019 - Signed by the governor.
- Board Members: Refines Provisions Around Pupil Board Member Service, Assembly Bill 709 (Bonta).
- Attendance: Transfer Policy, AB 1127 (Rivas, Luz D), Interdistrict Attendance: Prohibition on transfers by a school district of residence. Status: 9/27/2019 Signed by the governor.
- Pupil Services: Bullying, AB 34 (Ramos D), Pupils: bullying and harassment prevention information. Status: 9/12/2019 Signed by the governor.
