### **RECOMMENDATION**

Receive and file the June 30, 2023, Detailed Investment Portfolio Listing.

### **DISCUSSION**

In compliance with the State of California Government Code as amended by Chapters 783 and 784, Statutes of 1995 and in compliance with County Policy, the Santa Clara County Treasury Investment Portfolio Report as of June 30, 2023, is submitted for your review and acceptance.

The attached detailed investment report lists each investment of the County Treasury Pool, as well as individual reports for specific investment funds that each school district or special district has in the County Treasury. The reports include the respective purchase and maturity dates, par value, amortized cost, market value, and yield to maturity for each investment.

A summary of market value versus cost is provided below for Commingled Investments of the County Pool.

The yield of the Pool on June 30, 2023, was 3.11%. As a comparison, on June 30, 2023, the yield of a 6-month Treasury Bill was 5.43%. A two-year Treasury Note was 4.90%. The State of California Local Agency Investment Fund (LAIF) yield was 3.17%.

Attached with the current investment-economic outlook is a schedule that lists the average weighted maturities and yield for the Commingled Investment Pool. Charts outlining investment concentrations and distribution of bond maturities are provided for the Pool. Also included is a chart showing the one-year history of the Pool along with interest rates offered by selected comparable instruments.

Securities are purchased with the expectation that they will generally be held to maturity, hence unrealized gains or losses are not reflected in the yield calculations.

The market values of Pool securities were taken from pricing services provided by Bank of New York Mellon, Bloomberg Analytics, dealer quotes, and an independent pricing service.

A combination of maturing securities, new revenues, and tax receipts will adequately cover the anticipated cash flow needs for the next six months. Cash flows are continually monitored and are considered paramount in the selection of securities purchased for the Pool.

### Economic Update and Portfolio Strategy

June 30, 2023

The US economy expanded at a 2.4 percent annual pace in the second quarter ending June 30th, 2023, after posting 2 percent growth in the prior quarter. Growth exceeded consensus forecasts and market expectations across the board. The economy has shown surprising resilience. Despite 11 interest-rate increases, of which, 10 were consecutive, making up the most concentrated Federal Reserve rate cycle in decades, the labor market has not experienced any significant weakening. Even though the pace of job growth has slowed, the labor market has remained robust. At the same time, inflation has cooled in recent months. Consequently, wage gains have begun to outpace rising prices, easing pressure on household budgets and strengthening consumer confidence. The consumer price index excluding food and energy, which economists view as the best indicator of underlying inflation pressures rose at an annual rate of 4.8 percent in June, the smallest increase since 2021. Moderating inflation without sizable job losses contributes to the growing optimism that the economy may avoid a recession.

After deciding not to increase interest rates in June, Federal Reserve Bank (Fed) policymakers resumed and lifted again borrowing costs at their July 2023 policy meeting. This was the 11th rate hike since March 2022 to curb inflation. The quarter of a percentage hike boosted the Fed's benchmark federal funds interest rate from 5.25 percent to 5.5 percent, the highest level in 22 years. Policymakers have engaged in the most aggressive monetary campaign since the 1980s to dampen inflation which in 2022 hit a 40-year high.

Fed policymakers have indicated that it is too soon to conclude that the bank has done enough, and inflation has been tamed. They intend to make upcoming rate decisions based on how the economy fares in the months ahead. Due to possible economic growth, the Fed may need to hike more than currently anticipated. While interest rate sensitive categories such as residential investment and consumption of durable goods continue to be luke-warm, other categories are boosting growth such as the Biden administration's climate-industrial policy initiatives. Analysts forecast the government will spend \$1.2 trillion over the next 10 years on tax credits and other subsidies to fight global warming under the Inflation Reduction Act.

The performance of financial markets including stocks and corporate credit spreads, which are forward-looking measures, also suggest that growth is accelerating. The S&P 500's total return year-to-date (7/31/23) is close to 20 percent while the Nasdaq-100 is up over 40 percent. Most importantly, the persistent strength of labor markets remain a key source of support for the economy and of sustained spending. Housing stats and home prices have been stronger than expected, providing the economy with additional support. After a brief dip last year, home prices are rising even in the context of high mortgage rates. Demand for homes throughout the U.S. continues to outpace supply.

A wide spectrum of key measures strongly indicates that inflation including labor costs has unmistakably moderated in recent months. Fed policymakers, who have been worried that rapidly rising wages could make it harder to get inflation under control took comfort in recent labor cost reports. The employment cost index, a broad gauge of wages and benefits, increased a mere 1 percent in the second quarter, marking the slowest advance since 2021.

The Bureau of Labor Statistics reported in its latest release of the Consumer Price Index (CPI), that inflation, as measured year-over-year, advanced 3 percent in June, the slowest pace since 2021. In a separate report, the Personal Consumption Expenditures Price Index (PCE), the preferred inflation gauge of Fed policymakers, rose 3 percent from a year earlier in June, the smallest increase in more than two years. Core prices which exclude volatile food and energy sectors and are regarded as a more reliable signal of underlying inflation, advanced by a less-than-expected 4.1 percent, also the least since 2021. Similarly, signs of slower price growth have been evident in prices paid by businesses. The Producer Price Index (PPI) has also trended lower.

Commodity prices are sharply lower since the middle of last year, when agriculture, energy and industrial metal spot prices hit peaks. As a consequence of lower commodity prices, import and producer prices are now lower. With the decline in commodity, import and producer prices, the prices of goods as measured in the CPI index have dropped which has been a key factor in the moderation of the overall index. It is important to note, shelter prices which comprise over 40 percent of core CPI continues to decline. Decreases in rent on new leases as existing leases expire are over time showing up as reduced housing services inflation.

Although the employment market is slowing, it is still exhibiting solid growth. Demand for labor continues to outpace supply. Firms are still hiring and raising compensation while companies find relative ease in passing price increases to customers. The U.S. economy added 185,000 jobs in June and 187,000 jobs in July. The unemployment rate fell to 3.5 percent in July from 3.6 percent in June, both near record lows. Most recent employment numbers are down significantly from a year earlier and below last year's average employment growth of about 400,000 a month. Wages continue to rise, with average hourly earnings growing 4.4 percent in July from a year earlier, and the same rate as in June.

The portfolio strategy continues to focus on the:

- (1) acquisition of high-quality issuers;
- (2) identifying and selecting bonds with attractive valuations;
- (3) appropriately sizing the liquidity portion of the portfolio to ensure adequate cash for near term obligations; and
- (4) ensuring that monies targeted for longer term investments are deployed in vehicles with favorable risk-adjusted yields.

### Portfolio Liquidity Adequacy, Review, and Monitoring

#### **Yield and Weighted Average Maturity**

The yield of the Commingled Pool is 3.11 and the weighted average life is 648 days.

#### **Liquidity Adequacy**

The County Treasurer believes the Commingled Pool contains sufficient cash flow from liquid and maturing securities, bank deposits and incoming cash to meet the next six months of expected expenditures.

#### **Review and Monitoring**

FHN Financial Main Street Advisors, the County's investment advisor, currently monitors the Treasury Department's investment activities.

#### **Additional Information**

Securities are purchased with the expectation that they will be held to maturity, so unrealized gains or losses are not reflected in the yield calculations.





**June 30, 2023**








### Distribution by Maturity






